Recidivism Rate - 1st Quarter
There were a total of 94 incidents where detainees were placed on Investigative Segregation during the 1st Quarter.
Of those 94 incidents, a total of 84 detainees were placed on Investigative Segregation.
Of those 84 detainees, a total of 74 detainees were involved in a single incident (88.1%)
Of those 84 detainees, 8 detainees were involved in two incidents (9.5%)
Of those 84 detainees, 2 detainees were involved in three incidents (2.4%)
