Recidivism Rate - 2nd Quarter
There were a total of 94 incidents where detainees were placed on Investigative Segregation during the 2nd Quarter.
Of those 94 incidents, a total of 78 detainees were placed on Investigative Segregation.
Of those 78 detainees, a total of 64 detainees were involved in a single incident (82%)
Of those 78 detainees, 12 detainees were involved in two incidents (15.3%)
Of those 75 detainees, 2 detainees were involved in three incidents (2.7%)

Recidivism Rate - 1st and 2nd Quarter
There were a total of 188 incidents where detainees were placed on Investigative Segregation during the 1st and 2nd Quarters.
Of those 188 incidents, a total of 142 detainees were placed on Investigative Segregation.
Of those 142 detainees, a total of 108 detainees were involved in a single incident (76.1%)
Of those 142 detainees, 24 detainees were involved in two incidents (16.9%)
Of those 142 detainees, 8 detainees were involved in three incidents (5.6%)
Of those 142 detainees, 2 detainees was involved in four incidents (1.4%)
