Recidivism Rate - 3rd Quarter
There were a total of 120 incidents where detainees were placed on Investigative Segregation during the 3rd Quarter.
Of those 120 incidents, a total of 90 detainees were placed on Investigative Segregation.
Of those 90 detainees, a total of 72 detainees were involved in a single incident (93.33%)
Of those 90 detainees, 11 detainees were involved in two incidents (12%)
Of those 90 detainees, 5 detainees were involved in three incidents (0%)
Of those 90 detainees, 2 detainees were involved in four + incidents (2.67%)

Recidivism Rate - 1st, 2nd & 3rd Quarter
There were a total of 308 incidents where detainees were placed on Investigative Segregation during the 1st, 2nd, and 3rd Quarters
Of those 308 incidents, a total of 200 detainees were placed on Investigative Segregation.
Of those 200 detainees, a total of 139 detainees were involved in a single incident (69.5%)
Of those 200 detainees, 33 detainees were involved in two incidents (16.5%)
Of those 200 detainees, 17 detainees were involved in three incidents (8.5%)
Of those 200 detainees, 7 detainee was involved in four incidents (3.5%)
Of those 200 detainees, 2 detainee was involved in five incidents (1%)
Of those 200 detainees, 1 detainee was involved in six incidents (.5%)
Of those 200 detainees, 1 detainee was involved in seven incidents (.5%)
