Recidivism Rate - 4th Quarter
There were a total of 94 incidents where detainees were placed on Investigative Segregation during the 4th Quarter.
Of those 94 incidents, a total of 81 detainees were placed on Investigative Segregation.
Of those 81 detainees, a total of 72 detainees were involved in a single incident (88.9%)
Of those 81 detainees, 6 detainees were involved in two incidents (7.4%)
Of those 81 detainees, 2 detainees were involved in three incidents (2.47%)
Of those 81 detainees, 1 detainees were involved in four incidents (1.23%)

Recidivism Rate - 1st, 2nd, 3rd & 4th Quarter
There were a total of 402 incidents where detainees were placed on Investigative Segregation during the 1st, 2nd, 3rd, and 4th Quarter
Of those 402 incidents, a total of 253 detainees were placed on Investigative Segregation.
Of those 253 detainees, a total of 173 detainees were involved in a single incident (68.38%)
Of those 253 detainees, 40 detainees were involved in two incidents (15.81%)
Of those 253 detainees, 22 detainees were involved in three incidents (8.7%)
Of those 253 detainees, 12 detainee was involved in four incidents (4.74%)
Of those 253 detainees, 4 detainee was involved in five incidents (1.58%)
Of those 253 detainees, 0 detainee was involved in six incidents (.0%)
Of those 253 detainees, 2 detainee was involved in seven + incidents (.79%)
