It is unlawful to bring upon the institution grounds any weapons, intoxicants, drugs, or other contraband. This applies to any person who provides, or attempts to provide to a detainee anything whatsoever without the knowledge and consent of the Warden. All persons entering upon these premises are subject to searches of their person, property (including vehicle), and packages. The Warden, upon reasonable suspicion that a person may be introducing contraband or demonstrating actions that might otherwise endanger the institution safety, security, or good order, may request the person, as a prerequisite to entry, to submit to a visual search, or other comparable test. A visitor may refuse a search or test, which will result in the visitor not being permitted to enter the institution. Smoking is prohibited on institutional grounds. Please advise the officer if you require the Facility to store your important personal medication for you during your visit. If so, the officer will maintain the medication at the inner lobby desk.

This attestation form is required for all attorneys and their staff entering the Wyatt Detention Facility to acknowledge their awareness of the Facility's contraband policies, specifically regarding K2 (synthetic cannabinoids), and to affirm their due diligence in ensuring that no contraband, including K2 or other prohibited substances, is brought into the Facility.

BE **S.M.A.R.T.** PROTECT YOURSELF AND YOUR CLIENTS FROM K2 RISKS

K2, also known as synthetic marijuana or “Spice,” is a dangerous synthetic cannabinoid. It is often sprayed onto paper and smuggled into correctional facilities. Even innocent legal personnel and documents can be used for trafficking, putting **lawyers, staff, and detainees at risk.**

S – Screen All Papers

- ◆ **Inspect** every document before bringing it into the Wyatt facility.
- ◆ K2-laced papers **look normal** but can be toxic or deadly.
- ◆ Watch for **odd smells, discolored spots, or glossy textures.**

M – Minimize Risk

- ◆ Only bring in legal papers that **come directly from your office** or the **Court.**
- ◆ Avoid accepting **unexpected or third-party documents.**
- ◆ Opt for **digital paperwork** as much as you can.

A – Ask If Unsure

- ◆ If someone asks you to bring in documents that you are not sure about, **ask questions**
- ◆ If a document **looks or smells suspicious**, consult Facility security.
- ◆ When in doubt, **do NOT bring it inside** the Facility.

R – Refuse and Report Suspicious Activity

- ◆ **Refuse** any request from family members and others who ask you to bring non-legal or questionable papers into the Wyatt facility.
- ◆ Take appropriate action if you suspect **tampered** or unusual papers.
- ◆ Watch for **detainees requesting specific papers or extra copies** or **folding and hiding** paperwork you give to them.

T – Train Your Team

- ◆ Educate **your staff** about K2 risks.
- ◆ Establish **strict office policies** on handling legal papers.
- ◆ Keep up with **Facility rules** on document security.

⚠ REMEMBER:

Bringing in K2-laced papers could put your **law license, safety, and the well-being of our staff and detainees at risk.**
